INSTRUCTIONS FOR COMPLETING THIS RETURN

Item 1. Total Receipts from room rentals

Enter the total amount of all rents collected for the period covered by this return. Includes all nightly rates/rents and cleaning fees collected during this reporting quarter through all platforms (including online platforms). This does not include any host or other platform fees.

Item 2. Exemptions/Exclusions

- a. Enter the total amount paid for rooms which have been occupied for a period longer than 30 days. Exemption certification needs to be attached.
- b. Enter the total amount paid for rooms occupied by officials or employees of federal, state, county or city governments, or foreign governments while on official business. Attach exemptions certificate.

*Subtotal the exemptions

Item 3. Taxable Rents

Enter the taxable receipts: subtract the exemptions total (2) from the total receipts (1).

Item 4. Tax Due (to San Bernardino County)

Multiply the amount of the Taxable Rents (3) by 7% to determine the TOT tax due for payment.

Item 5. Tax collected and remitted through Online Platforms

Include all tax collected via any online platform and provide verification via host page. This includes the nightly rate and applicable cleaning fees taxed at 7%, host and other platform fees are not included in this calculation.

Item 6. Tax payable by Operator

Subtract line 5, TOT collected online from line 4, tax due to San Bernardino County.

Item 7. Penalty for Late Payment

A 10% penalty is assessed on payments received/postmarked after Delinquent Date; A second 10% penalty is added one month after the Delinquent Date based on amount in line 6.

Item 8. Interest

Interest of 0.5% per month (or portion of) is assessed on the amount of tax due from the date it became delinquent until paid. Interest is a cumulative total until paid based on amount in line 6.

Item 9. Credit or Charge from Previous Return

Any credit or charge will be added by our TOT Department. If you believe you have a credit, supporting documentation must be attached for consideration.

Item 10. Total payments

To calculate the total tax due take the Total Receipts (line 1), subtract the exemptions (line 2) to determine the taxable amount. Multiply the taxable rents (line 3) by 7% to determine the tax due. Subtract tax collected by online platforms (line 5) for balance of tax payable (line 6). Add any late penalties (line 7) or interest (line 8) and then add or subtract any amount from previous return (line 9). The balance in line 10 is the total tax payment due to San Bernardino County.
